CEN/BT Resolution:

BT C060/2011

BT

- accepts Mandate M/488 'Mandate to CEN, CENELEC and ETSI for standardization in the field of air conditioners and comfort fans', as in Annex to BT N 8639;
- allocates the work to CEN/TC 113 'Heat pumps and air conditioning units'.

This resolution is applicable as from: 2011-06-21

CCMC note: After the adoption of Resolution BT C60/2011, it appeared that CEN/TC 156 and CLC/TC 59X would also contribute to the work to be carried out under Mandate M/488.

CENELEC/BT Decisions:

D139/C105 BT, noting the German comments and the CLC/TC 59X advice thereon, accepted EC Mandate M/488 concerning the execution of standardization work on air conditioners and comfort fans.

D139/C106 BT referred the coordination of the response to Mandate M/488 to CEN and invited CLC/TC 59X 'Performance of household and similar electrical appliances' to liaise with CEN/TC 113 'Heat pumps and air conditioning units'.
