CEN/BT Resolution:

BT C052/2011

BT,

- noting that:

- EC Mandate M/490 "Standardization Mandate to ESOs to support European Smart Grid deployment" has been approved by CENELEC;
- the existing CEN-CENELEC-ETSI Joint Working Group on Standards for Smart Grids is adapting its structure and Terms of Reference to reflect those principles governing the work of a coordinating body associated with the standards producing system;
- a proposal that this Joint Working Group be re-organized to become a Smart Grids Co-ordination Group (SG-CG) as well as a document presenting its revised structure and composition were sent to the CEN and CENELEC BT Members on 2011-04-15, for comments prior to submission to the JPG meeting of 4 May 2011;

- decides to:

- accept Mandate M/490 to support European Smart Grid deployment as included in BT N 8599 (Annex 2);
- allocate the coordination of the response to Mandate M/490 to the group that will be converted from the existing CEN-CENELEC-ETSI Joint Working Group on Standards for Smart Grids, i.e. the proposed Smart Grids Co-ordination Group (SG-CG).
